

The Fall Fair Safety Information

The safety of our guests, volunteers and employees is our top priority. Red River Exhibition Park is committed to providing attendees with a great event experience in a safe atmosphere.

Please note that your access to or attendance at Red River Exhibition Park is conditional on your acceptance of the rules (listed below). We hope you enjoy your visit!

RULES:

1. All protocols related to COVID-19 must be adhered to. Please refer to the COVID-19 FAQs for details.
2. Tickets and passes are non-transferable, non-exchangeable, non-refundable, revocable and void if altered.
3. All persons, bags, parcels, clothing and other items are subject to screening and security checks at Red River Exhibition Park entrances and also within the Park.
4. All guests must pass through a metal detector to enter Red River Exhibition Park. Anyone declining the walk through will not be permitted into the Park.
5. We reserve the right not to allow any bag or other items into Red River Exhibition Park. All guests should familiarize themselves with the Red River Exhibition Park's list of prohibited items. Prohibited items should be kept at home or can be voluntarily surrendered at the entrance. Surrendered items will not be returned.
6. Please show common courtesy to fellow Red River Exhibition Park guests, volunteers and employees by not using profanity or engaging in unsafe, illegal, disruptive or offensive behavior.
7. For the comfort of all guests, smoking of tobacco, e-cigarettes or other products that produce a vapor or smoke are allowed only in designated smoking areas. Marijuana (for medical purposes or otherwise) and illegal drugs will not be allowed on Red River Exhibition Park property.
8. In keeping with our family-friendly atmosphere, proper attire, including shoes and shirts, must be worn at all times.
9. Laws prohibiting consumption of alcoholic by minors, illegal drugs, and disorderly conduct of any kind will be strictly enforced. All guests are encouraged to drink responsibly. Please do not drink and drive.
10. Access to attractions depends upon the safety rules of each attraction.
11. Amusement rides will be available at Red River Exhibition Park during The Fall Fair. We expect guests who seek to enjoy such rides to:
 - Exercise good judgment
 - Act in a responsible manner
 - Comply with all specific guidelines posted at the entrance of every ride
 - Obey all oral and written warnings and rules
 - Properly use all ride safety equipment provided

PROHIBITED ITEMS:

For the safety of all guests, the following items are prohibited at Red River Exhibition Park:

- All forms of knives, scissors, blades
- Firearms, slingshots, ammunition
- Conducted Energy Weapons (i.e. Taser)
- Replica firearms or weapons
- Hand tools or electric tools
- Alcohol
- Drugs, drug paraphernalia, illegal substances
- Drones or radio-controlled devices
- Skateboards, Segways, scooters, bicycles, shoes with wheels
- Mace, pepper spray, bear spray
- Paint or markers
- Fireworks
- Explosives, flammable items, ignition devices
- Compressed and/or aerosol sprays (except personal care products such as insect repellent)
- Light emitting devices such as lasers
- Banners, signs, voice amplification devices
- Air horns or noisemakers
- Sporting goods such as baseball bats, hockey sticks, golf clubs
- Pets other than animals with a Service Dog Identification Card
- Materials of an extremist, offensive or discriminatory nature
- Pad locks, chains, cables, zip ties, handcuffs
- Flyers, samples, promotional items, giveaways
- Articles of clothing with offensive language or images
- Any item deemed a danger to public order and safety
