No outside food or beverages are permitted.

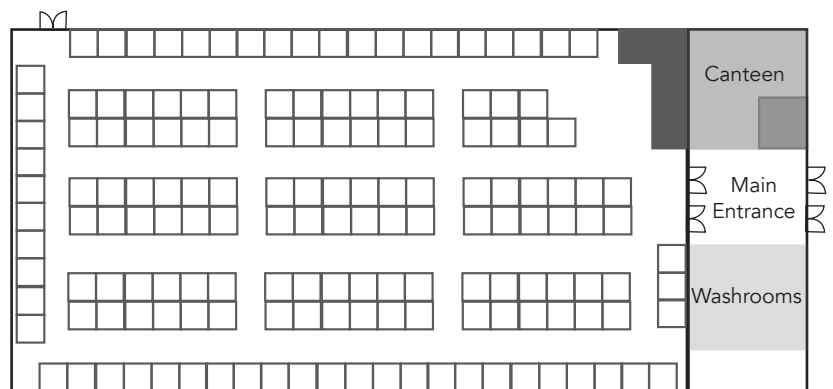
Canteen Hours: 9:00am - 6:00pm, August 12-14.
